Dear Parents/Guardians:

It is with great pleasure that I welcome back our K-3 students in a hybrid fashion this coming week. We are excited to see our K-3 kids that have opted for hybrid learning and look forward to the time when our 4th and 5th graders will join us. Below is some important information that will outline the transition plan for ALL students, K-5.

- **Kindergarten – 2nd Grade:**

- Hybrid: those students previously signed up for hybrid learning will continue their hybrid school days as previously done. Hybrid learning will resume the week of January 25, 2021 with their current teacher. Please be sure that you child(ren) are ready to attend on their assigned cohort days.
- Remote: Students who were learning remotely prior to our last closure will remain remote with their current teacher.
- If you have a child who is remote and you would like them to attend school in the hybrid model, you must call the school and ask to be placed on the “waitlist”.

- **3rd Grade:**

- Hybrid: Those families who opted for hybrid learning will begin hybrid instruction the week of January 25, 2021. Please note, that in some cases, your child’s teacher may have changed. It is my hope that your child attended the meet and greet this past Friday. All families have been informed of which cohort days their child will be attending. If you have any questions, please call the main office.
- Remote: Those families who opted to continue virtual learning will remain in this platform for the remainder of the school year. Please note that, in many cases, your teacher’s child may have changed. This was necessary to accommodate the hybrid model. It is my hope that your child attended the meet and greet with their teacher this past Friday.
- If you have a child who is remote and you would like them to attend school in a hybrid model, you must call the school and ask to be placed on the “waitlist”.

- **4th Grade and 5th Grade:**

- Hybrid: Those families who completed the survey and opted for hybrid learning will begin in-person instruction **the week of February 22, 2021.** Please note, that in many cases, your child’s teacher may have changed. This was necessary to prepare for the upcoming transition into the 3rd quarter of school. These teacher placement changes will take effect
